#### Vote YES for Open Space

The New Britain Borough Council recommends a *YES* vote on the following Open Space Bond Issue which will appear on the May 20<sup>th</sup> primary ballot:

"Should debt in the sum of \$59 million for the purpose of acquiring and preserving open space be authorized to be incurred as debt approved by the electors."

The \$59 million would be borrowed in three phases: \$35.9 million in 1997, and \$11.55 million each in the years 2000 and 2003, and would be divided into four categories:

Municipal governments, \$20 million County parkland, \$16.5 million Farmland preservation, \$13.5 million Natural areas, \$9 million

The tax impact to the average county tax payer is estimated to be about \$25 a year for over 10 years.

The allocation of \$20 million to municipalities will be based on population and will require a 25 percent match.

Council feels this is a good way to protect valuable open space in the Borough and throughout the county.

## Tri-Municipal Panel Seeks Youth Input

New Britain Borough, Chalfont Borough and New Britain Township have joined together to study the possible need for after-school activities for our youth. Each municipality has contributed \$5,000 to fund a feasibility study to determine what activities would best attract youth, how the program should be organized, and the level of interest in such a program.

Area officials believe the young people need a place of their own to meet, to talk, and to participate in group activities.

"We want the information to come from the kids," said New Britain Borough Manager Bob Schaffer. To that end, students ages 12 through 17 are invited to participate in one of three Focus group sessions to be conducted on Saturday, May 17, each one and a half hours long. The session for 6<sup>th</sup> - 8<sup>th</sup> grade girls will begin at 10 a.m.; the session for 6<sup>th</sup> - 8<sup>th</sup> grade boys will meet at noon; and a session for 9<sup>th</sup> - 12<sup>th</sup> grade boys and girls will begin at 2 p.m. To encourage participation, students will receive \$20 for their involvement.

The sessions will be interactive and focus on what the youth like to do in their free time, when and where they would like to participate and what sort of supervision they suggest. Then both the students and their parents will be asked to complete a separate survey about the likelihood of participating in a youth program.

The findings and recommendations will be presented to the municipalities in June.

Depending upon the results, the municipalities may seek to ac-

quire or lease a building to be the home of the program.


#### 1997 Budget

The 1997 budget approved by Borough Council totals \$797,399. It became necessary to raise taxes for only the second time since an unprecedented 10 mill decrease in Building & 1991. In addition, the Occupational Grounds 201 Privilege and Per Capita taxes were rescinded at that time. Subsequently, a 3 mill Road tax was instituted in 1994 increasing the total to 18 mills, which has continued until the present time. The emergence of the earned income tax in the early 1990s provided new funding to help offset increasing expenditures. However, the budgets for 1995 an 1996 required using surplus funds to prevent a millage increase. Now, with those excess funds depleted and the current Borough revenues reaching a static level with no foreseeable additional sources of income, the only alternative was to increase the tax to maintain the basic essential services provided annually by the Borough.


The General Fund rate has been increased from 12 to 16 mills. The 3 mill Road Tax remains unchanged, 3.5 mills were added for Recreation, and 4.5 mills for Street Lights. This new assessment will cost the average homeowner about \$120.00 in 1997.

In paring down the budget, Council removed several road and drainage projects, deferred purchase of a new police car, and eliminated numerous miscellaneous items while reducing others to a minimum. A reality check of the situation became evident to Council and the difficult task of proposing a tax increase was the only

A 3 mill Fire Protection Tax provides funds for the two fire companies which serve the Borough, Doylestown and Chalfont.

## Hazardous Waste Collection

If you missed the May 10 collection held in Jamison, you still have a chance to safely dispose of hazardous materials. A collection will be held at the Upper Bucks Vo-Tech School, 3115 Ridge Road, on May 17, from 10 a.m. to 3 p.m. Items being collected include pesticides, toxic chemicals, batteries, oil-based paint, and caustic household cleaners. ## Door-to-Door Solicitation

As Spring arrives, so do door-to-door salespeople. If someone should come to your home peddling a product, ask him or her to show you a completed permit to solicit. Such permit cards are issued by the Borough to salespersons who have properly registered with the Police Department. If the salesperson cannot produce the proper paperwork, they are NOT authorized to solicit in the Borough. Even non-profit organizations are required to register, though no fee is charged. The only exception is religious organizations.

If you are unsure that a person is authorized to peddle in the Borough, please contact the Borough Police at 345-1080. It would be most helpful if you could provide the police with a physical description of the salesperson — approximate height, weight, hair style and color, age and clothing — and, if they leave the area, in which direction they went and a vehicle description. It would also help to know the item they are trying to sell and the name of the company for which they work.

For your own safety and privacy, please do not allow the salesperson to gain access to your residence, and if for any reason you feel threatened or unsafe, call 911 immediately.

#### A Note from the Tax Collector

The 1997 school real estate tax bills will be mailed during the first week of July. This year the school district requires that checks be made payable to the Central Bucks School District. Please note that your payment should still be returned to the Borough Tax Collector.

Failure to receive a bill does not excuse a property owner from payment in accordance with state law. Residents who do not receive tax bills in the first week of July should immediately contact the tax collector, Ann M. Teschner, 348-1638.

#### Roadway Improvements

A number of road improvement projects are slated for the coming season, as follows:

The existing traffic signal on West Butler Avenue at the Town Center Shopping Complex will be moved to the intersection of Sand Road and West Butler Avenue, which also combines with the entrance to Clemens Market. This change was necessitated by increased traffic at this location due to new businesses in the industrial area along Britain Drive.

Handicapped ramps will be placed throughout the Briarwood community and several other locations in the Borough. These ramps are mandated by state and federal laws and must be installed at all curb and sidewalk locations.

Cherokee Road will be reconstructed from Lenape Road to Pueblo Road with a new recycled base course and a bituminous wearing surface. The North Penn Water Company has installed a new water main at the same location.

Surface treatment of bituminous oil and chips will be made on the following streets in the Borough: Maple Lane, Maple Court, Lampost Road, Elm Terrace, Landis Mill Road, Britain Drive, Keeley Avenue, Hawk Circle and Sand Road.

Road repairs and Rolimac application will be performed on Lenape Drive and Ute Road.
