

Discussion following the presentation will focus on the possibility of establishing a joint historic group or society to research and document aspects of the area's history.

Disposing of Leaves

Waste haulers licensed in the Borough must pick up leaf/garden waste at least once a month. BFI collects yard wastes, which can include leaves, each Monday. Waste Management will collect leaves on regular pick-up days (their maximum of 5 containers, bags and cans, applies. Leaves can be placed in the regular yard waste containers or biodegradable paper bags - NO PLASTIC BAGS PLEASE. In addition, Waste Management will likely have 2 collections in the Fall specifically for leaves. Contact your hauler for more specific instructions.

Some environmentally sound ways to dispose of leaves are:

- ✓ Compost the leaves to create a valuable soil additive
- ✓ Spread leaves in wooded areas of your property.
- ✓ Shred leaves on your lawn by running over them with your mower, leaving remnants to break down into useful mulch which will benefit your grass.
- ✓ Leaves are "recycled" and used by William Hirst of Highland Hill Farm. Residents can drop off leaves at the farm located at 520 Dublin Pike or call for pick up at 345-0946.

If you plan to burn leaves, the Borough Ordinance sets forth the following rules:

- ✓ Public roads cannot be used for burning leaves.
- ✓ Leaves should not be burned when atmospheric conditions make fires hazardous. Choose a cool day with low atmospheric pressure (the smoke will dissipate more rapidly). Burn when the wind is calm.
- ✓ Fires must be continuously monitored until extinguished. Extinguishing equipment (hose, buckets of water, etc.) should be available.
- ✓ No fires are permitted after sunset.

Route 202 Bypass Update

PennDOT held the final public meeting on the Route 202 Alternatives on September 12 at Central Bucks West High School. The purpose of the meeting was to present to the public the Draft Environmental Impact Statement (EIS) and for publicinput in the form of written and oral testimony. This was the last chance to express opinions on the proposed 202 Bypass. The overwhelming majority of attendees and speakers were in favor of building the Bypass. Those who spoke against it were mostly people who lived in properties built in the last five years directly in the path of the proposed Bypass.

Outstanding Police Officers are Recognized

The Borough Police Department wishes to recognize the outstanding service provided to the community by two of its previous members. The Department has been through many changes recently, and part of that came about due to the resignation of these two officers.

Officer Howard Kramer worked as an officer with our Department for over 27 years, from April 1966 to 1994. During this time he was a reliable, conscientious and professional employee. He diligently came in at all hours and worked through all kinds of conditions. Officer Kramer left this Department to work full time for the Mansfield University Police Department. The community lost a good friend since he moved on.

Officer Robert Bair served as an officer with our Department for over 17 years from 1972 to 1996. He had many roles — as one of our training officers teaching self defense techniques, baton training, pepper spray training, first aid and CPR instruction. Officer Bair was the officer in charge during the Chief's absence. He was a hardworking employee who performed his duties at any hour under any weather conditions without ever voicing a complaint. He has left our Department to work as a family counselor and mediator. However, he continues to assist the Department with his teaching and serve the community as a member of the Zoning Hearing Board and as the Borough's Emergency Management Coordinator.

Roadway Improvements

Several projects this year are improving Borough roads:

Iron Hill Road: Reconstruction of the roadway base course was recently completed using a "cold-in-place recycled bituminous base course." A hot mix bituminous wearing surface was then added to provide a smooth finish. E.J. Beneman, Sinking Springs, PA, was the contractor for the base course and P.K. Moyer, Earlington, PA, place the wearing surface.

Sioux Road between North Tamanend and Keeley avenues: Reconstruction will begin in early October. The work will consist of the widening and total reconstruction of the existing base course and wearing surface. The contractor is S & H Landscape, Inc., Chalfont, PA. Work is expected to be completed by the end of October.

Route 202 at Town Center Shopping Center: Plans are underway to relocate the existing traffic signal at this site to the intersection of Sand Road, opposite the Clemens Market entrance. The change is expected to

greatly improve the access to Route 202 (W. Butler Ave.) for all local businesses and will provide a much safer connection for employees, visitors, trucks and the many Borough residents who use Sand Road frequently.

Pipeline Work Completed

Texas Eastern Pipeline Company has recently completed the installation of a new 30" gas main within their right-of-way in the Borough. The actual construction work progressed very quickly and relatively smoothly due to good weather and the Company's expertise in this type of work.

Despite some emotional trauma about the project, there were very few complaints from residents during the construction process.

Areas that were newly seeded have started to grow and full restoration of the affected areas should be completed this fall.

Changing Seasons



As this beautiful autumn weather inevidably gives way to winter, we will once again face the prospect of SNOW. Here is a review of the Borough's ordinance relative to snow and ice:[

- * Sidewalks should be cleared of ice and snow by at least 12 hours after the snow staps falling.
- * Parking on all Borough streets is prohibited during and after snow falls until the roads have been cleared. If snow is predicted, do not park your car on the road.
